### **NOTES: Proxies and Financial Statements**

#### **Proxies**

- i. At a general meeting each member may vote in person or by proxy.
- ii. On a show of hands every member present in person shall have one vote. On a poll every member present in person or by proxy shall be entitled to cast one vote on his or her own behalf and one vote for every member he or she represents by proxy.
- iii. There shall be no more than five (5) proxies held by a Member.
- A proxy must be a Member of the Alliance Française de Canberra. iv.
- The instrument appointing a proxy shall be in writing or in the attached form under the v. hand of the appointer or his or her duly authorised Attorney. The instrument appointing the proxy shall be deemed to confer authority to demand (or join in demanding) a poll and shall be in (or consistent with) the form provided in Appendix 2 of the Alliance Française de Canberra Constitution.
- vi. To be valid, the signed instrument appointing a proxy, and the Power of Attorney or other authority, must be deposited with the Secretary not less than 24 hours before the time of the general meeting (or adjourned general meeting) at which the person named in the instrument proposes to vote, or in the case of a poll, not less than 24 hours before the time appointed for the taking of the poll, otherwise the instrument of proxy shall not be valid.
- vii. A vote given in accordance with the terms of an instrument of proxy shall be valid despite the previous death or unsoundness of mind of the principal or revocation of the instrument or of the authority under which the instrument was executed if the Secretary has not received notice in writing of such death, unsoundness of mind or revocation before the commencement of the general meeting (or adjourned general meeting) at which the instrument is used.
- viii. If you are unable to attend the meeting and are entitled to vote, you have the right to appoint a proxy. You are requested to complete the form of proxy attached at Appendix 2. The proxy form and the power of attorney or other authority (if any) under which it is signed (or a certified copy) must be received by the Secretary of the Alliance Française de Canberra, at least 24 hours before the time for holding the meeting at the company's registered office at 66 McCaughey St Turner ACT, or email a signed copy to bob@7point.net.au
